Background Information:

The California Department of Education has made available a Small School District & County Office of Education Bus Replacement Program. This funding is provided to upgrade school buses to comply with 1992 federal safety standards. Priority will be for the purchase of new school buses to replace existing vehicles. Second priority will be to reconditioning existing school buses. Any remaining funds will be available for the purchase of new school buses to increase the fleet owned by the district or county office.

Seventy-five percent of the funds will be allocated based upon priority categories of vehicle age, mileage and type of vehicle. Twenty-five percent of the funds will be allocated based upon the condition of the vehicles replaced.

Applications have been made available for this program and are due to the state by January 11, 2013.

It is in the best interest of the district due to the age and mileage of Bus #5.

We are requesting permission to submit an application and participate in the Small School District and County Office of Education Bus Replacement Program.
