WHEREAS, the State of California is in fiscal crisis and negotiations have broken down at the State level to arrive at budget cuts; extend temporary tax increases; or impose new taxes, the Willows Unified School District Board hereby finds it necessary and in its best fiscal interest to eliminate the services as specified below effective at the conclusion of the 2010/11 school year.
