# RESOLUTION TO DECREASE THE NUMBER OF CERTIFICATED EMPLOYEES DUE TO A REDUCTION IN PARTICULAR KINDS OF SERVICES

WHEREAS, Education Code section 44955 permits the Governing Board to reduce or discontinue particular kinds of services not later than the beginning of the following school year; and

WHEREAS, the Governing Board of the Willows Unified School District has determined that it shall be necessary to decrease the following programs and services of the District no later than the beginning of the 2011/2012 school year; and

WHEREAS, it shall be necessary to terminate at the end of the 2010/2011 school year the employment of certain certificated employees of the District as a result of the elimination of the programs and services; and

WHEREAS, the Governing Board of the Willows Unified School District has further determined that among employees who first rendered paid service to the District on the same day, the order of termination will be based solely on the needs of the District and the students thereof;

THEREFORE, BE IT RESOLVED by the Governing Board of the Willows Unified School District that the following services shall be reduced or eliminated no later than the beginning of the 2011/2012 school year:
