### MES – Shirley Williams reported:

- 5<sup>th</sup> grade held a tamale fundraiser to help pay for Shady Creek. Thank you to one of the parents, Jacqueline Garcia, who donated the supplies and made all 96 dozen tamales. This fundraiser earned approximately \$1,700.
- 3<sup>rd</sup> grade classes have attended the Sacramento Wildlife Refuge on field trips.

- Enrollment is 611 students. Kindergarten classes are at 27 students, with 21 in the TK/K combo class.

#### WCHS – Dr. Geivett reported:

- Enrollment is 33 students, with a couple of more expected to enroll after break.
- One senior should be graduating by January.
- Pancake breakfast will be December 19, 2019, at 8:30 a.m.

### 4.4 Director of Business Services – Debbie Costello reported:

#### • New & Recent Funding:

- <u>CTEIG 2</u>: \$250,000 one-time funding for CTE programs (all pathways) to be used in the current year. It will be expended on teacher extra duty and statutory costs, classroom and program materials and supplies, student events and related travel, professional development, and equipment.
- Strong Workforce Program: \$75,800 in one-time funding for CTE programs (Ag & Health Science pathways) to be used in the current year. Ag program funds have been expended for the purchase of a Suburban to transport students to farm visits and other program activities. Health Science funds will be expended for professional development and classroom/lab equipment.
- O Gear Up: \$41,397 "Phase 1" funding was utilized from July 1, 2019 through September 30, 2019 for program materials and supplies, chrome book cart, furniture, professional development, and student and community presentations such as "Mister Brown". \$30,000 in "Phase 2" funding has recently been awarded for use during the remainder of the 2019/20 school year. Priorities and expenditure plans are currently being determined.
- Special Education Early Intervention Preschool Grant: \$288,319 in one-time unrestricted funds
  which can be used for any purpose. The funds are allocated at First Interim to offset part of the
  contribution to Special Education (SELPA costs) from our LCFF base funding.
- Other Programs: Recently submitted application for funding for CTEIG for next year and for the School Nutrition Equipment Assistance Grant. Also submitting the application for Strong Workforce Program funding for next year. Just received the agreement for the Every 15 Minutes grant.
- The District has committed to participating in the next round of the Classified School Employees Summer Assistance Program (summer of 2021) which provides supplemental income from the State to the District's less-than-12-month classified employees who elect to participate. Income threshold has been expanded for the next year, which should allow all eligible employees to qualify.
- CASBO published an article on December 10, 2019 unveiling the 2020/21 Budget Blueprint. Educational
  areas include: funding for preschools, expanding access to early care and education programs, help K-12
  school deal with funding needs and improve California's special education program, and higher
  education.
