4.1 Employee Associations (WUTA & CSEA)

Maddy Nissen, Willows FFA Chapter President reported:

- Annual tri-tip sandwich fundraiser was held on November 1, 2019. Over 800 sandwiches were sold earning approximately \$5,000. Thank you to volunteers who helped and community members who purchased the sandwiches.
- 120 fair applications were turned in. Awaiting to see the exact numbers of species.
- o 54 students applied to be part of the State FFA Conference. Applications were screened, and 32 were chosen to be interviewed. After interviews, judges will pick 24 students to attend.

- Murdock PTO raised over \$2,000 at the Fall Festival. Thank you to all who helped and attended. It was a

 - Swimming: Team had a top 10 finish at the Masters Tournament. Adessa Berglund, Lauren Taylor, Meggie Cole, and Gracie Flowerdew earned BVL All-League honors. Adessa Berglund, Lauren Taylor, and Gracie Flowerdew were recognized as Sierra Nevada Scholar Athletes.
 - Cross Country: Matt Garcia ranked as 2nd overall runner in MVL. Good chance to qualify for the State Meet.
