Mrs. Domenighini expressed her concerns regarding BP 9124 and BP 9324. She did not feel the President of the Board should have the right to consult the attorney unless they had prior approval of the Board. She wanted the Policy to be changed to reflect that. Discussion ensued.

2. (Action) Consider expulsion of Student #2008-09-02. Administration recommends: Student #2008-09-02 be expelled through the end of the spring semester of 2008/09. The expulsion shall be suspended and the student will be enrolled in Willows Community High School through the end of the fall semester. Upon successful completion of the Stipulated Expulsion Option, the student will return to Willows High School. Periodic drug testing will be completed at no cost to the District and the student should seek and show successful attendance in a substance abuse counseling program outside the District (at no cost to the District). A counselor/site administrator will review this contract with the student upon his/her return to school after signing this document. Any violation of the Stipulated Expulsion Order, which includes 30 hours of volunteer community service, will result in the Student's immediate expulsion and placement in the Willows High Community Day School without further Board Hearing. Mr. Parisio moved, seconded by Mr. Thompson, to accept the administration's recommendation. The motion passed unanimously with 5 yes votes.

C. HUMAN RESOURCES

1. (**Discussion/Action**) Possible budget cuts for 2009/10 school year – Mrs. Skala distributed copies of the budget. She and Mr. Rudy explained the District's financial situation and answered questions. After discussion, Mr. Parisio moved, seconded by Mrs. Domenighini, to approve the list of possible budget cuts. The motion passed unanimously with 5 yes votes.

D. BUSINESS SERVICES

1. **(Action)** Consider approval transfer from fund 20 (post retirement) to fund 17 (special reserve) to cover Designated Economic Uncertainty (DEU) levels. Mr. Parisio moved, seconded by Mrs. Ward, to approve the transfer. The motion passed unanimously with 5 yes votes.
