WUSD involved parents, teachers, and school staff in the development of the plan through staff and committee meetings, Zoom Meetings, and through surveys.

A description of how students will be identified and the needs of students will be assessed.

Reading, ELA, and Math are areas WUSD is focusing on improving. WUSD will use a variety of local and state assessments that include Map Growth, teacher referrals, interim assessments, etc. to identify students.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

WUSD will inform parents of the summer programs and after-school programs during the school year utilizing Blackboard to call, email, and text parents and guardians. Notices of tutorial services for each school will be sent home to parents, along with utilizing Blackboard communication. School Site Council, District English Language Advisory Committee, as well as each sites' English Language Advisory Committee will be meeting two to four times a year to discuss services and opportunities being offered at each school site. Bilingual Parent and Community Liaisons, school Counselors, digital marquee boards, District and school websites, and printed materials will all be effective

and essential communication methods. Surveys will continue to be conducted to obtain additional input from parents of opportunities for student engagement and achievement.

A description of the LEA's plan to provide supplemental instruction and support.

WUSD will offer expanded learning opportunities with strategic interventions and enrichment programs for grades TK - 8 and credit recovery opportunities for grades 9 - 12 during the summer of 2021 with priority for identified students in each program. Intervention Teachers will be hired for the start of the 2021-22 school year with 2 ELA and 1 Math Intervention Teacher at Murdock Elementary and 1 ELA and 1 Math Intervention Teacher at both Willows Intermediate School and Willows High School. Additional Instructional Aides will be hired to provide instructional support and remediation for general education and English Language Development students. Learning recovery and assessment tools, programs and materials, including MAP Growth, Reflex Math, Freckle ELA and Math, No Red Ink, and Get More Math will be provided to all schools to assist with identifying student needs and providing instructional support. Professional development funds will be allocated for certificated and classified staff to further instructional practices and to other classified staff to develop and enhance COVID mitigation strategies. Two districtwide bilingual parent & community liaisons will be hired to increase engagement, provide resources and guidance to parents, and to promote learning opportunities for students. These liaisons will coordinate school site and district-wide activities utilizing resource centers, technology, and other materials that will be developed on each campus. New College and Career Readiness Technicians positions will be created, with one at each school, to further support student success. Before and Afterschool tutoring centers, Saturday School, and expanded library hours will increase learning opportunities for our students. Many of these measures will be sustained beyond the scope of the the Expanded Learning Opportunities Grant funds with other COVID relief funds, including ESSER and GEER allocations.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

Federal Elementary and Secondary School Emergency Relief (ESSER) funds will be utilized for actual ELO plan implementation and operational costs that exceed the districts' ELO allocation and will also be utilized to sustain many of the ELO plan activities beyond the 2021/22 school year.

Additionally, ESSER funds will be utilized for allowable uses beyond those of the ELO grant funds, including:

- purchasing supplies to sanitize and clean district facilities
- providing PPE for students and staff
- purchasing and maintaining educational technology for students that aids in their education
- mental health services and supports

- additional summer learning and supplemental learning programs including after-school programs and addressing the needs of lowincome students, students with disabilities, English learners, migrant students, students experiencing homelessness, and children in foster care
- other activities that are necessary to maintain the operation and continuity of services by the District.

### **Expanded Learning Opportunities Grant Plan Instructions: Introduction**

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code* (*EC*) Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. ## **Instructions: Plan Requirements**

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, creditdeficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' socialemotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

• An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
